THIS TUITION AGREEMENT is between **BET SHIRA CONGREGATION** (on behalf of the BET SHIRA CONGREGATION EARLY CHILDHOOD CENTER) and _____, as parents (the parents are collectively referred to as the “Responsible Party”) on behalf of _____, (“Student”).

This Tuition Agreement is a legally binding contract upon acceptance by Bet Shira Congregation, 7500 SW 120th Street, Miami, Florida 33156.

1. Responsible Party hereby applies for Student to be enrolled in BET SHIRA CONGREGATION EARLY CHILDHOOD CENTER (“School”). This Tuition Agreement is on behalf of the Student and pertains to enrollment in class _____ for the **2021-2022** school year. The School reserves the right to determine class placement and final admission. These decisions rest with the school director, or her designee, in her absolute discretion. In the event that the Student is not accepted for admission by the beginning of the school year, this Application becomes null and void and all fees will be returned to the Responsible Party.

2. The Responsible Party will be liable for all tuition, fees and charges listed below. The School fee schedule for **2021-2022** is incorporated herein. All Tuition, fees and charges paid will be non-refundable. Enrollment is for the entire school year (____ June____) If for any reason your child must be withdrawn from the program before the end of the year, full agreed tuition amount must be paid up to date, deposit must be paid unless you have given the school 30 days written notice (beginning of a calendar month) prior to your child’s last day at the program.

3. The Responsible Party understands and agrees to be responsible for all fees of the Student, including but not limited to, tuition, materials and fees. All such charges must be paid when due. All financial obligations must be met in accordance with the terms of this Agreement. Failure to meet all financial obligations when due will result in the series of actions as specified in the School Policy Statement adopted in February 1994. A copy of the School Policy Statement is appended hereto and incorporated herein. The Responsible Party acknowledges receipt of the same and has read it prior to signing this Agreement. If the School retains an attorney to enforce this Agreement, then the Responsible Party shall be liable for all of the School’s attorney’s fees and costs, regardless of whether or not suit is brought.

4. **APPENDIX TO 2021-2022 TUITION AGREEMENT**-Policy Statement Adopted February 1994

In the event of delinquent accounts, the Responsible Party is subject to the following possible actions in the absolute discretion of the School:

1. The Student’s enrollment is forfeited for the following year.
2. Collections process may be initiated.
3. Student may be immediately suspended.

Payment Plans

Plan 1 PAYMENT - Full tuition is payable on June 30th, 2021.

Plan 2 PAYMENT - Tuition is payable in 2 equal installments set for the above on June 30th and January 5th.

Plan 3 PAYMENT - Tuition is payable in 10 equal installments set forth above commencing June 30th and on the 5th day of each month.

* If VPK Voucher is being used then deduct \$2,471

* Students enrolled in VPK with a voucher but wishing to add a half day on Friday requires a \$2,200 tuition payment.

All Age Groups (5 days a week)

NON-Refundable Registration Fee of \$900 includes security, materials, supply and building maintenance.

Deposit - 1 month of tuition required which will be applied to the last month of the school year by June 3rd, 2021.

We must be notified in writing on the first of the month in order to receive 1 month deposit back.

Sibling discount – A 10% discount will be applied towards older sibling.

Snack- Bet Shira will be providing a nutritious kosher snack for all children 15 months and up.

Meals– Due to new health regulations, Bet Shira will not be providing meals or snacks at this time.

Early Care / Extended Hours

Early Drop is available from 7:30 am to 8:30 am at the rate \$140 monthly or \$1,400 yearly.

Extended Day is available from 3:30 pm to 6:00 pm

Infant/toddlers \$15 hourly

2yrs-4yrs \$10 hourly
